Faculty

Maude Le Roux, OTR/L, SIPT, RCTC, IMC, CBIS has several years of field and supervisory experience in a variety of OT fields. She believes in being a life-long learner and attends conferences on nearly a monthly basis. An experienced Occupational Therapist (SIPT), she holds a DIR certificate and has completed several Sound Therapy certifications. Maude started her career in the field of psychiatry in South Africa and applies this work daily in her practice working with children with special needs. She has received mentoring from a known play therapist for several years and continues her training in both sensory processing and emotional processing as a life-long quest. Maude works with a team of OT, Floortime practitioners, SLPs, and PTs in her practice. She is well known for her experience and work with children who carry a diagnosis on the Autism Spectrum, Sensory Processing Disorder, and Dyslexia/ Learning Disabilities. Maude is a mentor to many therapists, including OT and DIR professionals internationally. She is frequently invited to speak at various parent groups and has presented at conferences in a variety of settings across the US and internationally. Maude is currently an elected board member of the International Association of Registered and Certified Tomatis Consultants and serves on the research committee for the same organization. She is a co-trainer of the Tomatis Training Team for USA and South Africa and has co-authored the first book in a planned series entitled, *The Listening Journey for Children*.

Description

This 2-day workshop provides an opportunity for pediatric therapists to discuss several areas of the socio-emotional development in children. The speaker will include background information of different theorists, such as Erikson, Piaget, Vygotski and others. Development will be discussed in detail and emphasis will be given in the shared boundaries of sensory and emotional processing. Interventions such as DIR/Floortime, Sand Tray and Attachment work will be included. The case studies will be interactive with audience participation and the therapists will leave feeling equipped to start new ways of thinking of children that may have confused them before.

This course will provide therapists with that missing link in the global understanding of children. The speaker's practical method of understanding meltdowns and dealing with meltdowns in a way that fosters opportunity for growth has been proven successful on a global basis. The essence of the course is framed upon having respect for the child, understanding the nature of his/her development from different frames of references, and being able to apply principles of treatment that would enhance the outcome of the therapist's current treatment plan. Emotion to Motion

Description:

Autonomic nervous system function, and subsequent emotional overlay, is a frequent component of the children in our care. Emotion to Motion was developed to bring new, innovative concepts of treating the emotional system as a primary avenue to develop the postural and motor skills of an individual. It uses recent research findings with a new twist to establish motor efficiency in all planes of movement. This program presents evaluation of movement components and their tie to the autonomic nervous system and primitive reflex system. Course content includes:

- Program development for clinic, home, and school.
- Reinforcement of basic systems of sensory awareness tied with autonomy of sensory and motor control.
- Promotion of moving through fear into safety.
- Establishment of new treatment protocols for children with arousal issues, developmental problems, learning difficulties, sensory and control issues.

This course will broaden clinical reasoning skills in assessment and treatment of issues related to arousal, processing, learning, and sensorimotor efficiency.

She uses Therapeutic Listening, Samonas sound therapy, CranioSacral therapy, lymphatic drainage of the brain and many other approaches. She has always been interested in learning many different theories and techniques and developing treatment programs that are eclectic and aimed at treating the whole person. Treatment of the neck as a priority has been her specialty for 24 years. Mrs. Ingram has practiced for 30 years in the schools, developmental centers, and the clinic. She specializes in treatment for children with a variety of needs from mild to severe.

Treatment of the Head and Neck: A Foundation for Oral Motor Function, Sensory Motor Processing & Motor Development

Description:

This course is presented to establish a protocol for evaluating and treating head and neck problems as a first step in viewing children with oral motor, developmental and sensory processing problems. Evaluation and treatment of a child's head and neck is essential for resolving structural problems that impair information from the cranial nerves. These issues are often seen as a central nervous system problem when the location of the issue is peripheral in nature and can block normal information to the mouth, sensory systems, motor system and the entire developmental process. These issues often occur with difficult births, falls, low tone, excessive positioning on the back, low vision, stress, and other developmental problems that put excessive stress on the head and neck. This problem will be linked to other related issues in areas of development so the participant will be able to establish a solid foundation on which to build skills.

Through this presentation and practice sessions, participants will learn to identify the symptoms of decreased information through the cranial nerves, the habilitation process and the impact this treatment can have on function. **Bring a yoga mat with you to use in this session.**
